ORDINANCE # 661

AN ORDINANCE OF THE CITY OF HARTFORD, SOUTH DAKOTA, AMENDING CHAPTER 5.01 – ALCOHOLIC BEVERAGES OF THE REVISED MUNICIPAL ORDINANCE 430 OF THE CITY OF HARTFORD, SOUTH DAKOTA.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF HARTFORD, SOUTH DAKOTA, THAT SECTIONS 5.0105, 5.0106, 5.0107 AND 5.0113 BE AMENDED OF CHAPTER 5.01 OF ORDINANCE 430 BE AMENDED AS FOLLOWS:

5.0105 Hours of Business. It shall be unlawful to sell, offer for sale, give away, serve, consume or allow to be consumed on the premise covered by the license any alcoholic beverages between the hours of 2:00 a.m. and 7:00 a.m. At 2:00 a.m. every on-sale dealer shall clear the premises of customers and patrons and shall not sell, serve, or allow to be consumed on the premises any alcoholic beverages. (SDCL 35-4-81.2)

5.0106 Repealed

5.0107 Hours of Sale. No on-sale or off-sale licensee may sell, serve or allow to be consumed on the premise covered by the license, any alcoholic beverages between the hours of 2:00 a.m. and 7:00 a.m. Sunday through Saturday. (SDCL 35-4-81.2)

5.0113 Persons Under Twenty-One (21). No on-sale or off-sale licensee may permit any person less than twenty-one years old to loiter on the license premises or to sell, serve, dispense, or consume alcoholic beverages on the licensed premises. (SDCL 35-4-79)

Exception: Any on-sale or off-sale licenses may permit persons eighteen years old or older to sell or serve alcoholic beverages if less than fifty percent of the gross business transacted by the establishment is from the sale of alcoholic beverages, or the licensee or an employee that is at least twenty-one years of age is on the premises when the alcoholic beverage is sold or served. For the purposes of this section, the term, to sell or serve alcoholic beverages, does not include tending bar or drawing, pouring, or mixing alcoholic beverages. (SDCL 35-4-79.4)
